# (i) Main insurance policy

At the Ordinary Council meeting on 11<sup>th</sup> June 2019, Council AUTHORISED the Town Clerk and Town Mayor to conclude the Insurance Policy renewal with effect from 1<sup>st</sup> July 2019 (Minute #83 of 2019/20). This process has now been completed and the renewal price is £10,020.51 (engineering insurance to be added at approximately £400.)

This represents an increase of £1342.67 (before engineering insurance) as Epping Town Council's buildings have been revalued. The potential subsidence claim for the Jack Silley Pavilion has not resulted in increased premiums at this time.

The policy price for 2018/19 was £8677.84 (£9035.36 with engineering insurance).

Please note: Council are in Year 2 of a three-year insurance policy.

## 20 CYBER INSURANCE POLICY 2019

When the General Data Protection Regulation (GDPR) came into effect on 25<sup>th</sup> May 2018, it highlighted the risk to data from cyber threats and specialist policies were evolving. It is now over a year since GDPR came into effect and insurance companies have now been able to develop policies based on actual statistics and the relationship between cyber threats and GDPR is more quantifiable.

Epping Town Council undertook GDPR training and put GDPR and data protection policies in place and to date, there have been no data breaches to report. Council commissioned a data audit and increased its cyber protection.

Cyber threats do, however, pose considerable risks to Town and Parish Councils and if a cyber attack was to occur, it would cause major disruption and problems.

The Town Clerk has provided an overview of cyber issues as per **Attachment N**, two quotations as per **Attachments N1** & **N2**, and a RECOMMENDATION.
